24/25-065 Apologies for absence

24/25-070 Planning Applications received between meetings - to note comments

The Chair had attended a Planning Review meeting at Barnsley Metropolitan Borough Council (BMBC) and had raised the issues of lack of communication and need for training.

24/25-073 Response to the consultation on PDNPA Local Plan

After discussion regarding major issues of parking and sustainable travel, it was **resolved** that the Chair and Clerk would reply to the consultation prior to the deadline.

24/25-074 Items to bring to the attention of BMBC Neighbourhood Services

- The replacement dog bin needs to be requested again at the top of Brookhouse Lane as it still had not been replaced

- There were issues emptying the bins in the Flouch car park due to barrier height.

24/25 -075 Footpaths and Public Rights of Way Issues

The organizer of a Fell Race Saturday 2nd February was notified to the meeting. **Resolved:** no comments.

24/25 -076 Roads, Transport and Parking

The Clerk read out the letter from BMBC Highways confirming that traffic restrictions will be implemented on the lower section of Gilbert Hill, in the form of “no parking” highway restrictions. This is following the work of the Parish Council to highlight the issues of inconsiderate parking in areas of the parish including Gilbert Hill.

Previously National Highways/South Yorkshire Police/BMBC Highways suggested some form of bollards along the A616. **Resolved:** The Clerk to request an update.

24/25 -077 South Yorkshire Combined Mayoral Authority Bus Franchising Review

After discussion, it was agreed that the Chair and Clerk would reply to the review to emphasise the need for public transport which is currently lacking.
