#### 24/25-051 Items to bring to the attention of BMBC Neighbourhood Services

- The original "heritage" bin outside the Waggon and Horses had been changed for a large industrial bin. After the Parish Council raised, with BMBC and the Conservation Officer, the issue of the size and colour of the bin which was not in keeping with the Conservation area, a new smaller black bin has replaced the previous one.

- The bushes affecting line of sight at Fulshaw Crossroads had been reported to BMBC.

- The replacement dog bin requested at the top of Brookhouse Lane (now without black bags too) had still not been replaced

- A request regarding larger bins in the laybys was still awaiting a response or action.
